Meeting Minutes - May 9, 2023

ECHO Chair, Clark County Councilor, Gary Medvigy, called the ECHO meeting to-order.

• ACTION: Minutes APPROVED with no objections.

DOCUMENT RECORDING FEES

Presented by Michael Torres, Greg Kimsey, & Mark Gassaway

- o Fees are collected by the County Auditor when real estate transactions are recorded.
- o Approximately 60% of these fees are retained locally for very low-income housing and shelters, or for homeless services, per State Legislation.
- o Approximately 40% of these fees are passed to the State and returned to local governments in the form of the Consolidated Homelessness Grant (CHG).
- o HB2060
 - Est. by RCW 36.22.178
 - "Affordable Housing for All" surcharge
 - Requires an interlocal agreement between the County and Cities
 - About one-fifth of DRF
 - Allowed uses:
 - Rent vouchers
 - Emergency Shelter Ops.
- o HB1359/HB2163
 - Est. by RCW 36.22.179
 - "Local Housing and Assistance" surcharge
 - Not covered by Interlocal
 - Goes to local governments with Homeless Plans
 - Allowed uses:
 - Operate the local Homeless Plan

CO-RESPONDER PROGRAM

Presented by Laura Nichols, John Moren, & Blaise Geddry

- o Adult Mobile Crisis (AMCI)
 - AMCI provides mobile crisis outreach services to adults having a mental or behavioral health crisis.
 - Their service area is all of Clark County.
 - They operate 24 hours a day, 7 days a week, and 365 days a year.
 - Their average response time is <30 min. through the SW Regional Crisis Line.
 - This program is 100% funded by Carelon Behavioral Health (formerly Beason Health Options).
 - In person response consist of:
 - MHP Mental Health Professional
 - MHCP Mental Health Care Professional
 - CPC Certified Peer Counselor
- o VPD Co-Responder program
 - CRESA texts or VPD calls AMCI staff directly (with out going through the SW WA Regional Crisis Line)
 which shortens the respond time to about 10 min.
 - Hours of Operation are M-F 8am to 12am. Only 1 VDP Co-Responder team is available during this time.

- o Clark Cowlitz Fire and Rescue Co-Response Pilot Program
 - Pilot went live 2023 for a 12-month pilot program.
 - MHP's co-respond to 911 calls alongside EMTs.
 - They are currently responding to District 3 only.
 - Their focus is on gathering data to build a case for sustainable funding.
