Grocery Cart Eyesores

Some might wonder what can be done about the abandoned grocery carts left by humans randomly throughout Clark County. Some have even referred to them as 3-D graffiti eyesores or four wheeled pests. Little do we know that each cart can cost the retail store over \$100 each. Stores provide them for the



convenience of gathering our goods and transporting the goods to our cars. Carts should be left and/or returned to their proper store. Taking a cart beyond the retailer's property can be considered a form of stealing and subject to a fine or jail time per offense. Some areas of the United States require stores to recapture their carts within 72 hours (3 days) of being notified of their location. Also in some parts of the country there are cart recapture services that collect carts and

return them for a fee. If you can identify an abandoned cart, it is best to contact the retail store owner of the location ASAP.

Clark College Opens New Culinary Institute

On November 28, Clark College officially launched their newly constructed Culinary Institute known as the Tod and Maxine McClaskey Culinary Institute. Their address is 1933 Fort Vancouver Way, 98663

This new \$10.5 million, modern, 20,615 square-foot facility provides a variety of fast, fresh and healthy dining options for students, faculty, staff and the general public.



The space features three kiosks, a full-service baking retail store and barista bar, and grab-and-go items. In 2018 a fourth kiosk and student-run restaurant will open. The facility also offers indoor and outdoor seating.

The McClaskey Culinary Institute is also home to Clark College's completely redesigned Cuisine Management and Baking and Pastry Arts Program. The design of the facility's space allows visitors to see and interact with students, bringing food preparation and learning to the whole college. The institute provides education for students, nutritious meals for students and a great place for the community to come in and be part of Clark College.

Sidewalks on NE 68th Street

On November 28, 2017 the Clark County's Board of County Councilors approved the go-ahead to use a \$105,000 Grant to investigate the design feasibility of constructing continuous sidewalks on one side of NE 68th Street (between NE Hwy 99 and NE 28th Ave). A field study and cost analyst will help determine the sidewalks' location. Other factors under consideration are: drainage needs; hillside slopes; power lines; tree obstructions; present and possible future developments along NE 68th



St.; population growth; etc. Several Board Members expressed a need for this street improvement to go forward based on citizen's public safety concerns. Clark County is working with the City Of Vancouver to tie in the sidewalk project with the portion of NE 68th St. (East of NE 28th Ave. to NE St. Johns Road) that falls under the jurisdiction of the City. The Board unanimously approved the proposed study known as the Capital Road Project No 372122.

The Dirt on Street Sweeper Collections



Ever wonder what happens to the material recovered from our streets during our bi-monthly street sweeper rounds? The debris is taken to several collection facilities thru out the City and County. At these facilities the materials are gathered into large piles that decompose similar to a normal compost pile. The piles do have some level of biological activity that helps break down the levels of petroleum hydrocarbons in the assorted materials.

The piles are turned/mixed periodically to speed up the decomposition. The end use of this material is determined by the analytes levels (MTCA cleanup standards) and regulatory agencies (Health Department and Washington State

Department of Ecology). Due to the amount of debris remaining (even after a screening process) and the source of the material, this is not something that would be placed in a public common area. This material is typically used in areas where public access is restricted or very minimal, but if analytes or debris are outside of regulatory parameters, they will send the material to a landfill.

The nature of the material sources and potential for unknowns to end up within this material makes it unlikely for future use in public access areas or marketing. This information was gathered from the Public Works Department.

Crime Tips

Burglary Prevention

Burglaries remain an ongoing problem in Clark County. Most residential burglaries occur during the daytime when most residents are at work. The Sheriff's Office recommends you secure your home before leaving and avoid leaving a hidden key near the door. Keep a watch on your neighbor's property and report any suspicious behavior by calling 911. If you are going to be out of town put a stop on your mail and paper delivery, set automatic light timers, and request your neighbors keep a watch on your property. You can also make your house a less attractive target by keeping hedges and bushes trimmed back, allowing open views to all sides of your home, and setting motion sensor lights.



Auto Prowls/Thefts

Vehicles are prowled or stolen every day in Clark County. Help prevent these thefts by removing valuables from your car and parking in highly visible areas. Electronics like GPS, iPods, and laptops stand out as quick cash to a crook. Garage door openers are sometimes taken to gain access to your house. Do not leave a running, unlocked vehicle unattended to "warm it up." These are easy targets for thieves on cold mornings. Always be vigilant and report people who appear to be going car to car, looking in windows.

Stranger Danger

Attacks from strangers are rare in Clark County but it is always good to use safe practices when in public. Keep yourself from being an easy target by maintaining good posture, make eye contact with others, and avoid items that limit your awareness such as headphones, cell phones, alcohol and drugs. It is always safer to travel in a group. Teach kids to avoid conversations with strangers and to yell for help if a stranger grabs them.

Clark County Sheriff's Office –Citizen's Academy

The Citizen's Academy is a 6-week program designed to provide citizens of Clark County the opportunity to learn about the Sheriff's Office.

The purpose of the Citizen's Academy is to increase understanding between the department and the citizens of Clark County through education. Citizens will become familiar with the many facets of the Sheriff's Office and local law and justice system. With an increased understanding, citizens of Clark County and law enforcement can partner together to realize realistic solutions to neighborhood problems relating to crime and the fear of crime. The Citizen's Academy begins in March each year.

The Citizen's Academy is a course specifically designed for citizens who are active in their communities and

who wish to learn more about law enforcement in Clark County.

311 for Non-Emergency Law Enforcement

Clark Regional Emergency Services Agency (CRESA) is excited to announce a new number for the community to use to report non-emergency law enforcement issues.

Historically, Clark County has had one number to call to connect with their local law enforcement. This meant that if you had a non-emergency complaint (like someone had stolen your bicycle overnight) you had no choice but to call 911 to report the crime. Community members can now call 311 or 360-693-3111 to reach the 911 dispatchers. Using this line will help prioritize incoming calls at the 911 center and keep 911 open for emergencies.

When you call 311 you may be placed on hold or you may be placed in a queue. You may hear a recorded message with information about alternative numbers or resources you may use instead of waiting for a dispatcher. CRESA is a busy place, serving as both the 911 answering point for all of incorporated and unincorporated Clark County and is also the dispatch center for local law enforcement and fire/EMS responders. Please be patient, as the same people answering 911 emergency calls and dispatching responders are the same people answering 311. If all dispatchers on duty are responding to 911 calls the 311 line may not be answered immediately.

A few guidelines to follow when you decide if you want to call 911 versus 311:

- Always use 911 for any fire and medical call, no matter how minor you think the medical complaint is.
- Call 911 if your police complaint involves a gun, is a crime happening now, or a situation that needs police to prevent or stop an injury or property damage.
- 311 is the alternative number to report non-emergency law enforcement related complaints.

If you are unsure, call 911 and we will get you the right help or refer you to the right resource. Visit www.cresa911.org for more information.

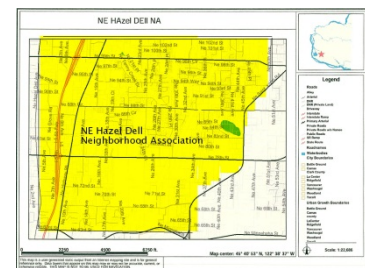
