ARPA SLFRF Preliminary Funding Allocation

\$94.7 M total Clark County allocation

- Funds will be received in two equal disbursements:
 - \$47.35 M received June 2021
 - \$47.35 M available June 2022
- Funds must be obligated (cost incurred) by December 31, 2024
- All funds must be expended by December 31, 2026.




Clark County Revenue Loss & Recovery

Estimated revenue recovery in 2021 is \$9.5 million for revenue loss in 2020.

- Approximately \$5.8 million of the recovered revenue is committed to general fund and the remainder is available to cover other general government expenses.
- Revenue recovery may be recalculated annually during covered fiscal years 2021, 2022, 2023 at the discretion of council.
- The range maximum allowable revenue recovery per year during the covered period would be approximately \$10 million.
- All recovered revenues must be reinvested in general government services.

Technology Services, Operations & Infrastructure Requests

Support for Community Services, Technology Services, Public Health, Prosecuting Attorney's Office, Indigent Defense and Facilities to address:

- Housing, rental & utility assistance, homeownership, and other services to prevent and combat homelessness \$15.5 M
- Enhancement of cyber security, technology and data systems \$10.0 M
- Staffing and equipment expenses to continue providing services for Public Health \$8.5 M
- Need for additional Prosecuting Attorney & Indigent Defense staff to address backlog of cases related to COVID-19 shutdown \$5.0 M
- Infrastructure investment to support safe and efficient facility operations and space reconfiguration.

Timeline for ARPA SLFRF Implementation

- ARPA signed into law March 2021
- Interim Final Rule (Guidance) released May 2021
- First half of funds released to County June 2021
- Treasury Reporting Guidance released June 17, 2021
- Council Work Session SLFRP Spending Plan June 30, 2021
- Treasury Final Rule available in July/August 2021
- Annual Recovery Plan Performance Report due August 31, 2021
