Ewe napenon kaputen anuen aramas, iwe ina a kan ew eorani non ach kei systems a kan chochono seni sukun tori tumunun safei tori atoto ngeni imw tori atoto ngeni monien momo, a kan maaketiw ew uruwo ren ese wewefengen ina a kan iseisenong me pwan katonong non unusen annukun fonuwach me pwan awenewenen fofor kena. Apechakunen sop-wesopwenon wewengawen wowngaw nefinen aramas pokiten anuwer a kan poputa seni napenon, iteiten osupwangen esapw chok seni ew fansoun manau, nge epwene unusen ew mwichen manau. 








Figure 4. Mochenin pechakunen inis

Figure 6. Mochenin Semwenin Napenap





Figure 7. Tit ren semwenin Napenap










Figure 10. Monitonong & pisekin mochen

Ewe Census Bureau a kan aweweni osupwangen mokutukut ren angeiin fakkun ngawen weires fiti ruwanu eom kewe akaewin neni ren fofor ena a pachenong rongorong, kuna, defines disability as having serious difficulty with four basic areas of functioning that include hearing, vision, sinei ia ka nom ie me tongeni fetan. 





Figure 14. Mochenin foforun angangen aninis


