## Purpose & Timeline

RCW 36.40 allows for supplemental budget appropriations for unforeseen and emergency situations.



#### Submission Deadline

All Change Requests for Supplemental are due to Budget Office

May 26, 2023

## County Manager Recommendations

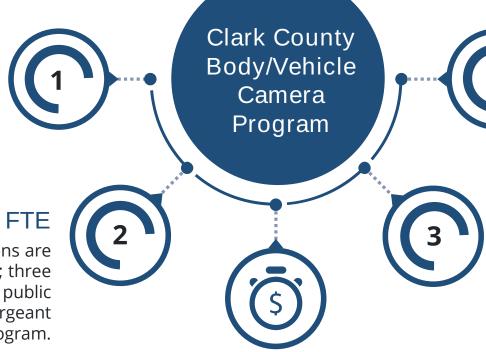
#### IT 2.0 FTE/PMO

These two new permanent technical positions are required for the initial configuration and setup of the body camera system as well as the ongoing support of the body camera program.

One-time PMO funding for program implementation.

#### Sheriff's Office 4.0 FTE

These four new permanent positions are required to maintain this program; three Support Specialist III positions for public disclosure and one enforcement sergeant to oversee the overall program.



#### 4 New Funding Requests

The Budget Office received a total of 4 New Change Requests from Departments and Elected Officials relating to the Body/Vehicle Camera Program.

#### Prosecuting Attorney 3.0 FTE

These three new permanent positions are needed to comply with the production of Public Records Requests, discovery obligations, and technical support for the body camera program.

# Prosecuting Attorney - Justice Premier Software

Funding for the Justice Premier subscription offered by Axon. The platform offers centralized evidence management, universal video playback, full redaction capabilities, and automated transcription functionality in a streamlined evidence management system via a CJIS-compliant, cloud-hosted environment.

# Body/Vehicle Camera Program

Recommendations address staffing and software needs for the County's new body/vehicle program.

# Public Safety Sales Tax Funding Advisory Committee

The Advisory Committee members shall include designees from each of the following departments/offices: Sheriff's Office, Jail Services Department, Prosecuting Attorney's Office, District Court, Superior Court, Clerk's Office, Juvenile Department, Indigent Defense, County Manager/Deputy County Manager, Budget Office, Information Technology, Finance Team, Facilities, two Clark County Council Members.

#### **Advisory Committee Scope:**

- Meet at least annually or as needed to provide oversight and review funding requests
- Make recommendations to the County Manager's recommended budget to the County Council
- Follow the eligibility requirements as described in RCW 82.14.340
- Make recommendations for performance review requirements for funded programs

**Advisory Committee Facilitation:** Facilitation of meetings and communications will be coordinated by the Budget Office.

#### 2024 Budget Process:

### **PFAC Timeline**

This will be the first year for both the new tax revenues and the Advisory Committee. Initial priorities are to ensure that commitments made to residents are funded, then to make recommendations for additional funding requests. September 2023

January 2024 **After Action Review & Next Steps** October 2023 Review and discuss the 2024 process and develop the next steps for the committee.

The committee will score all funding requests and finalize recommendations to the County Manager.

**Scoring and Final Recommendations** 

#### **Review 2024 Submissions**

Initial review of submissions for funding, discuss and finalize how the committee will evaluate and score requests for recommendations.

**Committee Kick-Off Meeting** 

Discuss the purpose and goals for the 2024 Budget Adoption and develop a process for review of requests and recommendations.

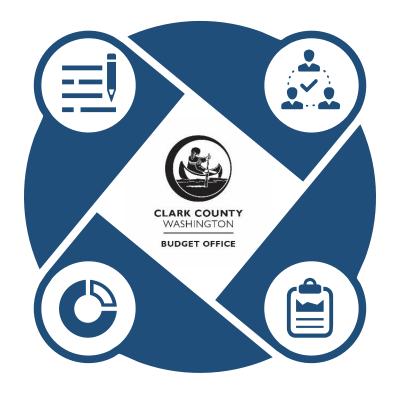
