Hello! to all our neighbors and new friends in Pleasant Highlands from your president, Stephan Abramson:

It has been more than a year since the coronavirus pandemic began and meetings and other normal social activities became difficult, if not impossible, to accomplish. We are pleased to be able to begin our reconnection with a very special neighborhood meeting for the evening of Thursday April 22.

Dr. Melnick will present an overview of the current status of the Covid-19 pandemic in Clark County and the county's efforts to control and mitigate Covid-19. He will also summarize the county's program to vaccinate county residents. His talk will include information on the characteristics, efficacy and safety of the Covid-19 vaccines available in the county and on how getting vaccinated will help us to expand our range of safe activities and return to a more normal lifestyle.

Deputy Harris will discuss enforcement activities in the county, and issues of recent concern especially to Pleasant Highlands. These will include porch pirates, mailbox vandalism and theft, vehicle theft and break-ins, and the county's enforcement effort regarding the thefts of catalytic converters from vehicles. As he did in our meeting in early 2020, he will be able to give us a perspective on how problematic these issues have been in Pleasant Highlands relative to other areas of the county.

We will also reserve part of the meeting to discuss plans for future neighborhood activities and to field questions and address concerns from our residents.
