is crazy and why won't staff explain themselves? This is not normal.

Gregory Shaw Staff wants us to endorse whatever "report" they write. Members can only

ask questions. Your insistence on a Parks conveyance is a clear example on how staff will not even acknowledge when they are using incorrect

data on the most basic question.

This is not about fonts, it is about allowing the public to have actual input

to the evaluation of overall site safety at Camp Bonneville. The proposed

charter severely restricts any public role.

Lou M (Guest) Who gets to see the public comments? CAG members? The public? Or just

staff? All other public comments in other county processes are provided transparently to the public. How do we know public comment will be addressed throughout the process so they can participate, follow, and

understand?

Gregory Shaw Kathleen just emailed me that she only responded to Ann's Charter email.

The rest of us did not apparently get it.
