The proposal is to revise the Clark County Capital Facilities Plan and its attendant Park Impact Fees (PIF). Staff presented five different scenarios for phasing in Park Impact Fee rate increases. When one of these proposals is approved, the new fee schedule will take effect January 1, 2017. The new Parks Capital Facility Plan and attendant PIF rates will be heard concurrently with adoption of the County budget, per RCW 36.70A.130(2)(a)(iv).

The Clark County Board of Councilors requested that staff investigate using a different approach to phasing in the increase of Park Impact Fee (PIF) rates, than the fee schedule that was adopted with the Clark County Comprehensive Plan update. Staff worked with a consultant to develop 5 different scenarios for phasing in new PIF rates. That report is included in this SEPA packet of information. The Board of County Councilors had adopted a new schedule to increase the Park Impact Fees, with 80% of the new PIF rate going into effect January 1, 2017. The Board now would like to consider a more gradual phasing of the new PIF rates than what was previously approved.
