The new Parks Capital Facility Plan and attendant PIF rates will be heard concurrently with adoption of the County budget, per RCW 36.70A.130(2)(a)(iv).*

The Clark County Board of Councilors requested that staff investigate using a different approach to phasing in the increase of Park Impact Fee (PIF) rates, than the fee schedule that was adopted with the Clark County Comprehensive Plan update. Staff worked with a consultant to develop 5 different scenarios for phasing in new PIF rates. That report is included in this SEPA packet of information. The Board of County Councilors had adopted a new schedule to increase the Park Impact Fees, with 80% of the new PIF rate going into effect January 1, 2017. The Board now would like to consider a more gradual phasing of the new PIF rates than what was previously approved.*
