**AMENDMENT
TO THE
INTERLOCAL CONTRACT
BETWEEN
CLARK COUNTY DEPARTMENT OF COMMUNITY SERVICES

CLARK PUBLIC UTILITIES**

This Amendment modifies the Interlocal Contract between the Parties dated January 1, 2004, pertaining to weatherization funding. The Contract is revised as follows:

**ARTICLE III
SCOPE OF CONTRACT**

Additional language:

On or about January 1, 2015 (or upon final invoice for the remaining 2014 funding), CPU shall transfer an additional \$200,000 to the County for use in the current year's weatherization program. These funds will be combined with any remaining funds previously provided by CPU under this Interlocal Contract. CPU will transfer another \$200,000 in weatherization funds to the County once all prior funds are expended. All funds shall be distributed pursuant to the Program Standards identified in existing Exhibit "A."

DURATION**






