**AMENDMENT #1 TO INTERLOCAL AGREEMENT
AMONG CLARK COUNTY, THE CITY OF VANCOUVER, THE EVERGREEN
SCHOOL DISTRICT NO. 114, AND THE VANCOUVER SCHOOL DISTRICT NO. 37
CLARK COUNTY SAFE COMMUNITIES TASK FORCE**

This Amendment is made by Clark County, the City of Vancouver, the Evergreen School District No. 114, and the Vancouver School District No. 37 for the purpose of amending the Interlocal Agreement referenced above, which was entered into between the parties in 2013.

WHEREAS the Interlocal Agreement ends December 31, 2013, and upon termination Clark County is required to reimburse the other parties proportionately and in a timely manner for any unspent funds through the date of termination; and

WHEREAS the parties do not anticipate that all performance objectives will be complete by December 31, 2013, and all parties believe that it is in the best interest of all involved to grant Clark County additional time to meet contractual performance objectives; and

WHEREAS the parties agree that the Interlocal Agreement should be amended to extend the term of the agreement;

NOW, THEREFORE, in consideration of the terms and conditions contained herein, and the continued consideration provided by and through the underlying Interlocal Agreement, the parties agree as follows:

1. Pursuant to Section 2 of the Interlocal Agreement, the term of this agreement shall be extended to December 31, 2014.
2. The intent of this amendment is to provide Clark County with additional time to expend funds disbursed by the parties in the original 2013 agreement. Therefore, Clark County, to align with their fiscal year will reconcile through December 31, 2013 and issue refunds for payments made in 2013. Following this process 2014 billings will be issued as described in the original Interlocal Agreement #2013-MH-75.
3. All other terms and conditions of the Agreement remain in full force and effect. The effective date of this amendment is January 1, 2014.




