

**NOTICE OF PUBLIC HEARING  
BOARD OF CLARK COUNTY COUNCILORS**

**NOTICE IS HEREBY GIVEN** that the Board of Clark County Councilors will conduct a public hearing on **TUESDAY, February 16, 2016, at 10:00 a.m.**, at the **Clark County Public Service Center, 1300 Franklin, Vancouver, WA**, to consider the following:

**RECONSIDERATION OF A PREFERRED ALTERNATIVE FOR THE 2016 COMPREHENSIVE PLAN UPDATE, and IF NEED BE, CORRECTING THE PREFERRED ALTERNATIVE MAP**

Clark County is updating its comprehensive plan to meet its 2016 Growth Management Act deadline. As part of the update process, the county is required to analyze the impacts of growth alternatives through the SEPA process. The county adopted the environmental impact statement (EIS) prepared for the 2007 update and prepared a draft supplemental EIS (DSEIS) issue in August 2015 to analyze four (4) potential growth alternatives for the 2016-2035 time horizon. The Board selected a revised Alternative 4 as the preferred alternative on November 24, 2015. On January 13, 2016, the Board had a work session to review the planning assumptions for the preferred alternative, and the Board decided at that time to revisit the preferred alternative.

The purpose of the hearing will be to review and reconsider the Board's selection on November 24, 2015 of a preferred alternative under SEPA; and, if necessary, to consider adoption of proposed corrections to the map for revised Alternative 4; and to take public testimony concerning the matter or matters being considered. A hearing regarding corrections to the revised Alternative 4 map was originally scheduled for Tuesday, January 19, 2016.


