### Jeanne E. Stewart - District 1

Jeanne E. Stewart was elected to the Board of County Commissioners in November 2014. As of Jan. 1, 2015, each board member's title changed to councilor because Clark County moved to a home rule charter form of government. Councilor Stewart has pledged to "Work to provide all our citizens the responsible, effective, accountable and transparent government they deserve."

Before being elected to the county board, Councilor Stewart served 12 years on Vancouver City Council. In that role, she served six years on the C-Tran and Columbia River Economic Development Council boards and two years on the Regional Transportation Council. Earlier, she was appointed to a five-year term on the Vancouver Planning Commission.

Councilor Stewart worked for more than a dozen years in various accounting, finance and auditing functions at US Bancorp. She and her husband of 40 years ran a family business for 29 years, working as manufacturer sales representatives.

At Clark College, Councilor Stewart earned an Associate Degree in Arts and Science, with honors and an emphasis on business. She has been active in community affairs since 1981, when she began her public service work as cofounder of what became the Carter Park Neighborhood Association. She served as chair of the Vancouver Neighborhood Alliance and in numerous volunteer positions with Vancouver Public Schools.

## Verizon Installation in EMNA

Skip Greene will brief us on the Verizon Wireless proposal to install a new wireless communication facility at 5800 NE 53rd St. This is a City of Vancouver water tank property and the facility would be about 95' south of the water tank. It would consist of a 120' tall steel monopole that would be disguised as a pine tree (monopine).

The "tree top" would extend to 130' tall so that the monopine has the typical tree appearance. The branches would be placed on all sides of the monopine all the way down to 17' above ground line and the fenced compound for the cabinets would have the perimeter fully landscaped. The surrounding trees have heights up to 150' so this facility would only be seen from portions of the surrounding properties due to the "mini forest" behind the monopine location.

Changing the Router IP Address: changing the wireless "broadcast" name from the default router name, disabling the broadcasting of the name, and changing the default wireless router's default password is specific to each router company's product (there a multiple Wi-Fi router companies such as Dlink, Belkin, Linksys, Netgear, 2Wire, etc).

A Google search for "change wireless network name insert specific router name" (e.g. Netgear)" will provide instructions to change the publicly visible network name so it doesn't indicate the specific router type.

## Hints from Mike Rollins

A Google search for "insert specific router name disable SSID broadcast" should provide step by step instructions. Note, disabling the network name (SSID) broadcasting will hide your network name from the average Joe, but it's no roadblock for anyone intent on hacking into a network.

By turning off the broadcast of the SSID, your network will not appear in a site survey. Site Survey is a feature of many wireless network adapters on the market today. It will scan the "air" for any available network and allow the computer to select the network from the site survey. Turning off the broadcast of the SSID will help increase security because the only way a computer can join the network is by setting the computer's SSID to the specific name of the network.

A Google search for "insert specific router name change default password" should provide ample instructions on how to do same.

The aforementioned steps requiring the user to make changes to the router's configuration so while you are at it you should confirm the following encryption is set on the router:

## Free Prescription Discount Cards Offer Savings For County Residents

Clark County residents can save money on prescription drugs by using the county's free prescription discount drug program, Public Health officials said Tuesday.

Since the program started in late 2006, county residents have used prescription discount cards to fill approximately 279,400 prescriptions. Residents received an average discount of nearly 27 percent on each prescription, which amounts to an average savings of \$11.31 per prescription. From November 2006 through March 2016, Clark County residents saved a total of \$3.16 million.

The National Association of Counties sponsors the prescription drug discount card program. The cards are free and may be used by all county residents regardless of age, income or existing health coverage. They are accepted at most pharmacies. A Spanish language version of the card is available.

Cards are available at city halls, libraries, participating pharmacies and C-Tran transit centers throughout the county. They also are available at these Clark County facilities:

- Center for Community Health, 1601 E. Fourth Plain Blvd.
- Public Service Center, 1300 Franklin St.
- Auto Licensing, 1408 Franklin St.

Residents can use the card when insurance does not cover a prescription. There are no enrollment forms, restrictions or limits on how many times the card can be used.

### Annexation Questions Asked

- County Park Levy assessment: When city annexes do they still pay the County levy as well as the city tax?
- Kelly Park and Tower Crest Parks are on schedule to be developed, what will happen to them?
- County maintenance parks fee (Metropolitan Parks District Levy) is part of taxes, will they have to pay both the parks district levy and the city taxes after annexation, or will the County levy fees be discontinued upon annexation date?
- Questions on water and sewer systems – is there a requirement to transfer to city services? And how will that happen? Timeline? Costs? (Some residents are on septic systems.) **ANSWER:** No. You can continue to use a septic system and/or well after annexation, unless there is a system failure and a determination is made by the Clark County Public Health District that connection to a public sewer system is required.
- Zoning change questions: Will there be changes to zoning and what is currently allowed? **ANSWER:** Following annexation, the City will assign the same or most similar zoning designation to what currently exists in Clark County.
- City rules for livestock on property? Are they more restrictive? **ANSWER:** Current legal uses will be allowed to continue in the manner that it exists at the time of annexation.
- Sidewalks! Concerns over level of service and how to get some of the current gaps completed, especially near Vancouver Mall. **ANSWER:** The City values the role sidewalks play in providing safe and enhanced walkability throughout neighborhoods and business districts. Following annexation, the City will evaluate each of the public streets within the annexation area to determine the need for sidewalk and other pedestrian mobility improvements. The needs for each street will be prioritized and incorporated into the City's pedestrian improvement programs.
- Concerns expressed over potholes on 62<sup>nd</sup>. Kudos given to county on sidewalks being installed from 58<sup>th</sup> to Andresen.
- Neighborhood association boundaries. City annexation will create some new neighborhood boundaries. Upon annexation, the City will work with all newly annexed residents to establish city neighborhood associations. When the time comes to be welcomed into the Vancouver program, the city is excited to have this active neighborhood join them. The City's Neighborhood program was started in 1975.

## CITIZENS ADVISORY BOARD MEETING

Clark County Sheriffs' Commander Kasberg and Deputy Tom Dennison gave a presentation to the Citizens Advisory Board meeting on January 14, 2016 on their Use of Force Policy & Procedures. They felt that police officers in the Northwest area have the best training on Use of Force across the nation. Their training should enable them to avoid the sad situations involving use of force that has been happening in the Midwest and East Coast.

They shared part of the training they give to all police officers. They stated that use of force is a decision composed of three questions:

**Is it... Feasible?**

**Is it... Tactically Sound?**

**Is it... Permissible?**

Excessive force must pass a reasonableness test. A reasonableness determination is based on whether the officer's actions are "objectively reasonable" in light of the facts and circumstances confronting them, without regards to their underlying intent or motivation. Four factors to be considered in this analysis: whether the suspect poses an immediate threat to the officers or others; the severity of the alleged crime; whether the suspect is actively resisting arrest and, whether the suspect is attempting to escape. Unfortunately sometimes a decision must be made in a split second.

They shared several case histories in our state and other states. The ah-ha! moment for me was the understanding that the moments before the actual use of force is most likely the determine factor of the outcome. In other words did the officer do everything in his capabilities to avoid a confrontation that leads to use of violent force or did the officer create a violent situation. Be a little leery of sensational news stories about victims of excessive force because some of the facts are not stated due to the ongoing investigation of the case (police officers cannot comment on current cases) and therefore only one side is making claims and accusations. **(Contributed by Jim Foley)**



## RUN, HIDE, FIGHT

### Wonder What You Should Do If You Encounter An Active Shooter?

Sgt. Alex Schoening, Clark County Sheriff's Office, recommends that each of our residents take a few minutes to review the video which provides key steps individuals should take in this situation. It is produced by the City of Houston, TX and found at

The City of Houston Mayor's Office of Public Safety and Homeland Security produced the informational video Run. Hide. Fight. Surviving an Active Shooter Event for citizens in the Houston Region, funded with Homeland Security Grant funds, which reenacts various Run. Hide. Fight. scenarios. The video encourages citizens to evaluate the situation and:

1. Run if a safe path is available. Always try and escape or evacuate even if others insist on staying.
2. Encourage others to leave with you but don't let the indecision of others slow down your own effort to escape.
3. Once you are out of the line of fire, try to prevent others from walking into the danger zone and call 9-1-1.
4. If you can't get out safely, find a place to hide.
5. When hiding, turn out lights, remember to lock doors and silence your ringer and vibration mode on your cell phone
6. As a last resort, working together or alone, act with aggression, use improvised weapons and fight.

Rosemary Fryer, Vancouver Public Schools Board Member, shares this program was implemented in 2014 and all VPS teachers have been trained. Questions: Call Mick Hoffman at 360-313-1247.

## "Run - Hide - Fight"

At the April Citizens Advisory Board Sergeant Bill Sofianos gave an informative presentation on **Identifying – Reacting and Surviving an Active Threat**

**"Run – Hide – Fight"**

**RUN** – away from danger

**HIDE** – in a safe and secure place

**FIGHT** – only as a last resort

Starting in 2013 responding to an "Active Threat Situation" schools started moving from the traditional response to the **Run-Hide-Fight** Philosophy.

Clark County Sheriff Deputies are teaching Clark County's students to "run-hide-fight" should they ever be faced with an active-shooter situation. "It's not our intention to instill fear. We want to provide a greater level of awareness for the students," said Sheriff Chuck Atkins. "Although an active shooter incident is extremely rare, unfortunately, it's the reality of the world we live in today."

Leading this trend, Hockinson School District is the first in Clark County to implement this program. Deputy Jason Granneman, School Resource Officer for the Hockinson School District, gave the "Run-Hide-Fight" presentation to the students during a school assembly. "The kids already know about active shooter incidents. This instruction course brings students into the conversation for the first time informing them on what to expect"

Superintendent Sandra Yager endorsed this effort: "As an educator I believe education is the answer. The more we know the better prepared we are for any potential circumstance."

## Washington State Primary

### DID YOU KNOW?????

The following question was posed to both the CC Democratic Party office and CC Republican Party Office regarding the voting process.

**IT IS MY UNDERSTANDING THAT AN INDIVIDUAL NEED NOT IDENTIFY A PARTY PREFERENCE WHEN REGISTERING TO VOTE IN THE STATE OF WASHINGTON. THUS -- JUST WHO WILL RECEIVE A BALLOT TO VOTE IN THE MAY ELECTION: EVERYONE? HOW DO THOSE WHO PARTICIPATED IN THE DEMOCRATIC CAUCUS GET REMOVED FROM THE MAILING LIST, OR DO THEY VOTE ALSO?**

**This is a portion of the response from Kenny Smith:**

CC Republic Party: (No response was received from the CC Democratic Office.)

We have never registered by party affiliation in Washington State. I think we are one of 6 states that do not. So there will be two ballots sent to all registered voters, a Democratic ballot and a Republican ballot. There will be a place on the envelope to declare your status as Republican or Democrat and then you will fill out the proper ballot. The elections office will verify signatures as they always do, but will also verify that the correct party affiliation has been declared for the ballot enclosed.

So while we have never registered by party affiliation, there have been times in our history where we have had to declare party affiliation to vote on a party ballot. The secretary of state will retain the party affiliation information for only 6 months, if I recall correctly, and then it will be destroyed. However, that party affiliation is public record for a limited period and will be available to the parties (and others). Some have wondered if people will vote on the opposite party ballot, but the secretary of state does not believe that Republicans will want to go on record declaring affiliation with the Dems and vice versa which will end up being a part of everyone's records.

You might be surprised that there will be a Democratic ballot sent in the mail, since the Democrats have stated they will not use the results of the primary to select their candidate. The presidential primary was instituted by the legislature in 1989 and it would take an act of the legislature to change or eliminate it. They did cancel it in 2012 due to budgetary concerns, but it is right back on the calendar for 2016 because it was not eliminated, just cancelled that one year. They really have no choice except to conduct a primary on the third Tuesday in May since that is what the legislation required. The primary is essentially a poll done on behalf of the parties that they are free to use as they see fit.

The presidential election is like no other due to the way the founders set up the Electoral College system and the way the political parties have developed their nominating systems over the decades. It causes a lot of confusion because it happens only once every four years and the public does not understand how the parties can make up their own rules about how the nominee is chosen and does not even have to use the results of the state's primary.

## Clark County's GIS Dept.

One of the original and most important functions of our county government is to serve as the land office. The land office is responsible for keeping track of who owns the land. In 1990 Clark County began migrating the hand drawn property maps started in 1844 to a computerized mapping system called a Geographic Information System (GIS). The department's name also changed from the Mapping Department to the GIS Department. In recent years the GIS department has moved from its traditional home in the Assessor's Office into the Information Technology Department which reflects its transition to a technology and information sharing organization as much as a mapping department.

Clark County's GIS program has continued to evolve with the rapid changes in technology. Clark County has been a leader in sharing public records on the web via the popular [Maps Online](#) and [Property Information Center \(PIC\)](#) websites. These web resources have become indispensable to our community. The PIC and Maps Online have become a widely used community resource used by home owners, many agencies, and business in the community.

- Realtors use the PIC to see what schools children will attend.
- Banks use the PIC to verify property information for new home purchases.
- Builders use Maps OnLine and the PIC to determine the development potential of a parcel.
- Utilities use the PIC to verify property owner information before connecting new services.
- The GIS Vacant Buildable Lands Model is used to determine how much land is available for development.

The Property Information Center is the most popular GIS resource. It is a one-stop shopping center for information about Clark County. What most people don't know is that much of the information on the PIC is actually gathered from the map layers you see in Maps Online. The PIC includes links to Maps Online that show the supporting map layer(s). The convenience of the PIC report makes it unnecessary to use Maps Online for much of the most popular information.

While it may not be necessary to use Maps Online for most property information, it can be fun to explore the layers in Maps Online to find things like parks and trails or historical aerial photos.

Maps Online has a catalog of over a 150 different map layers. This can make it a little daunting to find the information you are interested in finding. Here are some tips and tricks to using Maps Online.

- Use the "i" identify icon to make a layer *active*. Once a layer is *active* you can click on those features in the map to learn more about the features. By default the property layer (taxlots) is the *active* layer.
- The layers are grouped into MapSites which contain similar layers. There is a MapSite button on the left and right side of Maps Online. Each offers a different way to find a MapSite.
- Use the "Find Layer" search tool to find layers. Try finding trails or surveys. Find Layer will automatically make the layer you select *active*.

Clark County has many other online resources to help answer your questions.

The CC Community Development Department emails out a development review status report every Friday. 
