

**BOARD OF COUNTY COUNCILORS

The Board convened in the Councilors' Hearing Room, 6th Floor, Public Service Center, 1300 Franklin Street, Vancouver, Washington. Chair Marc Boldt, Councilor Jeanne E. Stewart, Councilor Julie Olson, Councilor David Madore, and Councilor Tom Mielke present.

Further discussion ensued about consent agenda item #2. Horne joined the discussion. Further discussion ensued about changing the Board time format. Discussion ensued about discussing the 2% levy certification letter and set a public meeting on January 12. Mielke spoke about his concerns with revisiting the 2% issue. Madore spoke about utilizing the County's best practices. Stewart stated her concerns with the 2% property tax reduction and spoke about the alternative plan she offered. She spoke about funding for the Sheriff's office and stated she would like to revisit the issue. She also spoke about a letter the County Manager received from Auditor Greg Kimsey and Treasurer Doug Lasher. Mielke stated his concerns with revisiting already passed issues. Madore spoke about following proper process. He also spoke about the fee waiver program. Olson stated she would like a general fund update. Madore spoke about a previous RTC Meeting. Boldt inquired about setting a public meeting. Horne responded. Further discussion ensued about the budget.

ACTION: Moved by Stewart to bring back next Tuesday in a Public Meeting reconsideration of the levy certification letter. Olson seconded the motion. Further discussion ensued. Madore stated for the record his disbelief of the motion. Chair Boldt, Councilors Stewart and Olson voted aye. Councilors Madore and Mielke voted nay. Motion carried.


