**Legal Matter**

**ACTION:** Moved by Stewart that the Board of Clark County Council authorize and approve the global settlement of the Washington Counties Risk Pool vs Clark County matter consistent with the terms described in executive session and authorize the Prosecuting Attorney to sign all related documents. Olson seconded the motion. Chair Marc Boldt, Councilors Stewart, Olson, Madore, and Mielke voted aye. Motion carried.

**Market Place Fairness Act**

Mark Gassaway, Financial Director, presented and referenced a packet titled "The Truth about the Marketplace Fairness Act." He asked the Council to support House Online Sales Tax Legislation. Mielke stated he thinks they should be going through the State Legislators. Gassaway spoke about other organizations supporting the act. Madore stated he supports the benefits but believes it does more harm than good for business owners. Further discussion ensued about the benefits of the act. Stewart spoke about going through the local State Legislators to try to change on the federal level. Further discussion ensued. Madore stated his concerns on how it might affect small businesses. Chris Horne, Deputy Prosecuting Attorney joined the discussion. Stewart stated she wanted to discuss it further before moving forward with the letter. Gassaway stated he would get more information for Stewart and Olson before next week's board time. Madore inquired about standardized tax payments and to report filing for all 50 states.

Bill Richardson, Prosecuting Attorney's office joined the discussion and spoke about a settlement agreement regarding the parties to Ellis, et al v. Clark County et al.

**ACTION:** Moved by Olson to authorize the Board of Clark County Council to sign the settlement agreement described in executive session. Stewart seconded the motion. Chair Marc Boldt, Councilors Stewart, Olson, Madore, and Mielke voted aye. Motion carried.
