**Legislative Update with Mike Burgess**

Mike Burgess, County Lobbyist presented. He provided a general overview / timeline. He updated the Board on bill updates on SB 6334 / HB 2468 - rail dependent uses for purposes of the growth management act and HB 2379 / SB 6585 – Elder Justice Center. He also spoke about HB 2945 – Growth Management Act (GMA) Task Force, SB 6570 – Model Toxics Control Act (MTCA) Funds. Further discussion ensued. Jeff Swanson, Economic Development Director joined the discussion. Burgess also spoke about HB 2576 – Public Records Relief. Further discussion ensued. Madore inquired about the local representatives positions on the issues. Burgess responded. Further discussion ensued. Burgess is going to do more research and bring it back to the Board. Madore inquired more on SB 6548 – allowing the use of gender segregated facilities. He stated he would like to support the bill at this time. Mielke agreed on supporting the bill. Boldt stated he would like to get more information about it first. Stewart inquired more about the timeline and asked for more background about bill. Burgess responded. Further discussion ensued. Swanson inquired about HB 1438 – permitting cities, towns, and counties to prohibit the production, processing, and sale of marijuana under initiative measure No.502 only by public vote. Burgess responded. Further discussion ensued.

**Letter: Re: Current Tax exemption for municipal bonds 2016**

Mark Gassaway, Finance Director, presented a draft letter to the Board to present to the Committee on Ways and Means and Committee on Finance to stress the importance of maintaining the current tax exemption for municipal bonds.

**C-Grid**

Boldt inquired on the C-Grid. Madore responded. Further discussion ensued about the C-tran documents. Mark McCauley, County Manager joined the discussion. Swanson brought up the C-Grid on his iPad and read off the topics listed on the C-Grid. Further discussion ensued about the purpose of the C-Grid. Further discussion ensued about the C-tran lawsuit and reference documents. Further discussion ensued about using county related services to reference personal facebook material. Stewart, Boldt, and Stewart expressed their concerns with the material on the C-Grid. Further discussion ensued about the purpose of the C-Grid.






