

CS 16-21 AGREEMENT TERMINATING THE INTERLOCAL AGREEMENT

OF THE SOUTHWEST WASHINGTON BEHAVIORAL HEALTH REGIONAL SUPPORT NETWORK

This agreement to wind up the affairs of the Southwest Washington Behavioral Health Regional Support Network is entered into this 28th day of June, 2016 by and between the Skamania County, Washington (“Skamania”) and Clark County, Washington (“Clark”) (collectively the “Counties”).

WHEREAS, the Counties, together with Cowlitz County formed Southwest Washington Behavioral Health (“SWBH”), a Regional Support Network (RSN) pursuant to a certain Interlocal Agreement for Joint Regional Support Network effective as of July 16, 2012 (the “July Agreement”) ; and

WHEREAS, the Counties with Cowlitz County amended the July Agreement to terminate the participation of Cowlitz County effective as of July 1, 2015, and left all other provisions thereof intact; and

WHEREAS, the Washington State Legislature passed a law which changed the delivery method for medical, behavioral, and chemical dependency services. Clark and Skamania Counties chose to become an Early Adopter to implement full Medicaid integration ending the need for regional support networks to deliver those services; and

WHEREAS, as of April 1, 2016, the Washington State Health Care Authority contracted with third party Managed Care Organizations to administer and manage the programs and duties described in the original Interlocal agreement, pursuant to RCW 74.09.035; and

WHEREAS, the SWBH RSN Interlocal agreement between the Counties is no longer necessary or in the public interest.




