RESOLUTION NO. 2014-03-08

A RESOLUTION declaring the intention of the Board of County Commissioners to investigate the possible partial vacation and abandonment of a **portion of NE Repass Road**.

WHEREAS, an application has been received alleging said road is no longer being used and will not be used. Now, therefore, IT IS HEREBY DIRECTED that the Director of Public Works shall examine and report in writing his opinion on the advisability and propriety of vacating and abandoning that portion of Road described as follows:

Legal Description

Partial road vacation of NE Repass Road

A 50 foot wide strip of land located in the Northeast Quarter of Section 10, Township 2 North, Range 1 East, of the W.M., Clark County, Washington and further described as follows:

All that part of NE Repass Avenue as shown on the plat, Alexander Tracts, as recorded in Volume "E" of Plats, Page 1, records of Clark County, Washington lying between the Westerly right-of-way line of Pacific Highway, more commonly known as NE Highway 99 and the Easterly right-of-way line of Interstate 5.

Containing 14,421 sq. ft. or 0.33 acres more or less.

Clark County shall reserve an easement for all existing utilities.






