4) FIP Updates - Justin Collell

- a) Recap of Outreach The Home and Garden Idea Fair and the Clark County Fair were both successful. Several phone calls regarding Italian Arum. Good outreach with guest Pamela Moody who has Policeman's helmet near her front door.
- b) Civil Infractions
 - i) Providence Padden Paid in full: Civil infraction NWCB-1012 in the amount of \$1,500 for failing to control Poison hemlock on two parcels, 2nd year infraction.

- ii) City of Camas Paid in full: Civil Infraction NWCB-1016 in the amount of \$750 for failing to eradicate Garlic mustard.
- iii) Vatik Dulo Paid in full: Civil Infraction NWCB-1015 in the amount of \$750 for failing to eradicate Garlic mustard.
- iv) Brad and Gary Strunk No response: Civil Infraction NWCB-1017 in the amount of \$500 for failing to control Tansy ragwort. Certificate of Lien pending.
- c) Tansy Signs Twenty-nine signs distributed, 8 retrieved, 21 lost. Bill mentioned Cowlitz County has a permanent sign and thought we might consider something similar.
- d) Project Positions County has converted four seasonal positions to project positions with one available for Field Inspection. Due to this conversion, there is a question of budget for seasonals. Justin would like more than one employee in each truck to assist in survey efforts. Randy asked about Larch Correctional Facility shutting down and Justin explained that it did hurt us during the tansy pulling season. It is unknown if we will have access to this type of crew in the future.
- e) Variable-leaf Milfoil Did not treat Warren Seely but did treat four other properties. One property refused treatment. Possibly treat Warren Seely in spring of 2024. Hybrid/crossbreed will be listed as class 'A' noxious weed in 2024.
