ALTERNATIVE SERVICE OPTIONS:

If you cannot find the person to personally serve them, there are two other options available. A judge must sign an order granting you permission BEFORE you serve this way. In the Motion you need to be specific about how you've tried to find the other person. The options are:

- Motion & Declaration For Service Of Summons By Publication **WPF DRPSCU 01.0260** – RCW 4.28.100; CR 4 (You need to list the ways you've tried to find the person.)

TO SERVE BY MAIL:
