Dear Historic Preservation Commissioners,

First, thank you all for your service to our community, helping to preserve and identify historic sites in Ridgefield and throughout Clark County. Ridgefield has a proud history that includes our connection with native peoples’ Cathlapotle settlement, our connection to the Lewis and Clark trail, and importantly – the settlement of Ridgefield in the 1800s by Union soldiers. The prevalence of Union soldiers’ history settling Ridgefield is easily seen in the early name of our City (Union Ridge), the potatoes those soldiers transplanted from Vancouver Barracks which became our High School’ s mascot, and the name Union Ridge for our first elementary school.

What Ridgefield does not have a connection with is the confederacy or any of the individuals who led it, including Jefferson Davis. Yet, every time there is a national story about confederate memorials, confederate flags, and the like, we in Ridgefield see our great City’ s name associated with a memorial that is NOT in Ridgefield, and has no connection with our history, who we are, or what we represent and support.

Because there is no historic or current connection between the Jefferson Davis Highway Marker and Ridgefield, and because it is still listed with, and identified by, an address in the Ridgefield zip code area, the City of Ridgefield asks that the Highway Marker be removed from the Clark County Historic Register.

Thank you for your consideration, and again, thank you for your service to our community.

We are hoping to have 100 people attend the hearing, with as many as possible giving testimony during the public comments portion. We have confirmed that KOIN 6 TV will be present, so the event will make Portland area news!

There will be a hearing regarding our request to remove the Jefferson Davis memorial from the Clark County Historic Registry. We are going to gather at Vancouver City Hall between 5:00-5:30. At 5:30, we will have a few brief speakers. At 5:45, we will begin going into City Hall to register for the public comments portion of the hearing. Hearing begins at 6:00 PM. I want to make it 100% clear, this is a peaceful, respectful meeting. If we encounter opposition - and we will - this is not the place to engage in verbal or physical confrontation. If we are going to be successful in our request, it is vital that we remain calm, collected and committed

to peace and non-violence!

### **Freedom Cities Update**

We learned yesterday that Vancouver Police Department agreed to adopt all the changes to their immigration policy that we requested. This is a huge victory for us! This does not mean that there isn't still work to do, but that they have adopted the official policy we wanted. We are waiting for that to be formally adopted, and once we have it, we will be able to leverage that into nailing down the Sheriff's Office into adopting the language as well.

TO THE CLARK COUNTY HISTORIC PRESERVATION COMMISSION:

I understand that this matter will be the subject of a hearing scheduled for Tuesday, October 3, 2017. As a proud resident of Clark County, I respectfully ask that the Commission take all steps necessary to **either** (1) remove the Jefferson Davis marker, as well as all mention of its placement by, and association with, the United Daughters of the Confederacy, from the Clark County Historic Register, **or** (2) require that any continued physical display and/or presence on the Register be accompanied by a full, detailed and honest identification of the United Daughters of the Confederacy as a national racist and white-supremacist organization long involved in fomenting, spreading and enforcing the Jim Crow culture of repression of the most basic civil rights of African Americans, as well as systematically spreading lies and myths about the horrors of slavery, the Civil War, and racial hatred generally.

The existing placement of the marker on the Register is entirely dependent upon a cynically false, or embarrassingly mistaken characterization of the United Daughters of the Confederacy as simply a “women’s rights” group which deserved recognition for its organizing efforts in establishing a system of highway memorials. There is nothing in the public record to indicate the existence of any connection between that group and Clark County. Maybe the Commission’s earlier failure to appreciate the true nature of the United Daughters of the Confederacy can be chalked up to ignorance; but, today, a basic search of internet sources (e.g., Wikipedia) quickly reveals the United Daughters of the Confederacy to have been, for well over a century, a thinly-veiled front for the systematic spread of racial hatred and white-supremacy.

From a purely technical standpoint, it’s hard to believe that any possible historical significance of the Jefferson Davis marker, however characterized, can be said to have survived the Washington Legislature’s recent decision to completely eliminate that name from the old designation of HWY 99 on a statewide basis.

Far more importantly, Clark County simply needs to completely disassociate itself from the vestiges of the cultural vision represented by Jefferson Davis and the United Daughters of the Confederacy – particularly out of courtesy and respect for our present and future citizens of African-American heritage for whom the history of slavery and the on-going threat of subjugation by white-supremacists is a daily lived reality – as well as all Clark County residents for whom the goal of real and decent racial justice is of the very essence of being Americans.
