# A. TITLE 40 UPDATE: HABITAT CONSERVATION & WETLAND PROTECTION ORDINANCES

The County is proposing to update portions of Title 40, the Habitat Conservation and Wetland Protection Ordinances. Clark County Department of Environmental Services proposes to update the wetland code to be consistent with the revised Washington State Wetland Rating System developed by the Washington Department of Ecology, and update remodeling, and replacement of existing structures.

## B. AMENDMENTS TO PROVISIONS REGARDING MASTER PLANNING

The Growth Management Act (RCW 36.70A.367) allows counties to establish up to two rural industrial land banks. The county received an application on February 2014 for a land bank site or sites along SR-503 north of NE 119<sup>th</sup> Street.

Clark County Code Section 40.520.070 contains provisions for master planning but does not include rural industrial land banks in the list of projects eligible to be master planned. County staff have proposed amended language in Section 40.520.070 and a new section (Section 40.520.075) that deals specifically with master planning for rural industrial land banks. In addition, staff propose minor changes to the code section (Section 40.560.010) dealing with changes in the comprehensive plan map relating to rural industrial development. #### C. AMENDMENTS TO PROVISIONS REGARDING MINERAL RESOURCE LANDS

As required by the Growth Management Act, and using updated information from the Washington Department of Natural Resources on the location of mineral resources in Clark County, the county in 2010 began a process to update comprehensive plan and development code provisions related to mineral resource lands and the location of surface mining overlays. To complete this work, the county needs to update 1) its designation of mineral resource lands; 2) the comprehensive plan policies related to mineral resources; and 3) the development regulations in the county-s development code (Title 40). The Board agreed in principle in June 2014 on an updated map to designate mineral resource lands.

The Planning Commission reviewed comprehensive plan policies and development regulations and made a recommendation to the Board of County Commissioners in December 2013. One of the recommendations was for staff to develop a section on monitoring and enforcement, a new Section 40.250.020(F). That section, along with a recommendation to make extraction, sorting and stockpiling of minerals a conditional use, is the subject of this hearing.
