MODIFICATION OF CONTRACT
BETWEEN **CLARK COUNTY**
AND

EDUCATIONAL SERVICE DISTRICT 112

The Contract entered into between Clark County, by and through its Department of Community Services, hereinafter referred to as the County, and Educational Service District 112, hereinafter referred to as the Contractor, is hereby modified as follows:

WHEREAS, the parties entered into a Contract for the period of July 1, 2014 through July 31, 2015 for Early Intervention Services in Natural Environments, and;

WHEREAS, the County has budgeted for this program; and

NOW, THEREFORE, in consideration of payments, covenants, and agreements, hereinafter mentioned, to be made and performed by the parties hereto, the parties covenant and agree as follows:

I. MODIFICATIONS

A. Total funding for the contract is increased by \$37,998.88, from \$88,854.88 to \$126,853.76.

B. The funds are added to Early Intervention Services in Natural Environments.

C. The modifications are shown in bold font in the Budget Summary, and do not alter nor nullify any of the remaining provisions of the original Contract.

II. REASONS FOR MODIFICATIONS

The Contractor is receiving additional funds because it is serving an increased number of children in natural environments.

III. ENTIRE CONTRACT

This modification incorporates the original Contract by reference. The parties agree that the original Contract and this modification are the complete expressions of the terms hereto and any oral representations or understanding not incorporated herein are excluded. Further, any modification of this Contract shall be in writing and signed by both parties. Failure to comply with any of the

provisions stated herein shall constitute material breach of contract and cause for termination. Both parties recognize that time is of the essence in the performance of the provisions of this Contract.

It is also agreed by the parties that the forgiveness of the non-compliance of any provision of this modification does not constitute a waiver of the provisions of this modification.
