2. MODIFICATIONS

- 2.1. For the 09/30/16 - 09/29/17 contract period, the budget for Statement of Work #1 is hereby increased by **\$10,000** from \$30,000 to **\$40,000**.
- 2.2. The total contract amount is thereby increased by **\$10,000** from \$60,000 to **\$70,000**.
- 2.3. All other terms and conditions of the original contract, as amended, remain the same.

3. ENTIRE CONTRACT

This modification incorporates the original Contract and any subsequent modifications by reference. The parties agree that the original Contract, subsequent modifications, and this modification are the complete expression of the terms hereto and any oral representations or understanding not incorporated herein are excluded. Further, unless provided elsewhere in the Contract, any modifications of this Contract shall be in writing and signed by both parties. Failure to comply with any of the provisions stated herein shall constitute material breach of contract and cause for termination. Both parties recognize that time is of the essence in the performance of the provisions of this modified Contract.

4. DEBARMENT OR EXCLUSION

From time to time, Clark County, WA (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
