Background

- Per RCW36.70A.470(2) Each county and city planning under RCW 36.70A.040 shall include in its development regulations a procedure for any interested person, including applicants, citizens, hearings examiners, and staff of other agencies, to suggest plan or development regulation amendments. The suggested amendments shall be docketed and considered on at least an annual basis, consistent with the provisions of 36.70A.130.
- CCC40.560.030 Amendments Docket This section is enacted pursuant to RCW 36.70A.470. This process is allowed per County and State Statute.



Process

- Based on the number of Docket Items & Annual Reviews staff will set schedule for Community Outreach, Planning Commission work sessions and public hearings.
- Approved Docket Items & Annual Reviews will be reviewed per criteria in <u>CCC40.560.010 Plan Amendment Procedures</u>. Staff will then create a staff report with a recommendation for approval or denial.
- Planning Commission will hold a work session and a public hearing and make a policy recommendation to the BOCC.
- BOCC will hold a work session and a public hearing to consider the PC recommendation and make a final policy decision.

- 5 proposed Dockets for consideration
 - > 2 Arterial Atlas Amendment
 - > 2 Comprehensive Plan map amendments and zone changes
 - > 1 Comprehensive Plan text amendments



Plan Text Amendment





 The atlas depicts the long range regional roadway system plan needed to support the land use plan and help fulfill the transportation objectives of the comprehensive plan.




