BACKGROUND

Clark County is acquiring this 5.19-acre parcel, zoned Rural-5 (R-5), as a mitigation site for Northeast Blair Road, Capital Road Project No. 322212. This project will improve the roadway surface and safety along Northeast Blair Road, from State Route 500 to milepost 2.47.

The 5.19-acre parcel is on the east bank of the Little Washougal River, south of Southeast Krohn Road. The \$128,000 purchase price is based on an appraisal.

None. Acquisition funds were included in the 2018-2023 Transportation Improvement Program and the 2018 Annual Construction Program.






