#### BACKGROUND

Clark County Public Works has partnered with the city of Ridgefield and Western Federal Lands, part of the Federal Highway Administration, to construct a bicycle/pedestrian pathway between Ridgefield and the Ridgefield National Wildlife Refuge, a distance of almost ½ mile. The proposed pathway along the west side of Main Avenue will provide safer access between the city and the wildlife refuge.

For efficiency, Ridgefield has offered to process the Shoreline permit for the city and county, instead of having two permitting processes. The Interlocal Cooperation Agreement authorizes Ridgefield to issue and administer the Shoreline permit in concurrence with Clark County Community Development (see attached Community Development memorandum).

### COUNCIL POLICY IMPLICATIONS

None. The Main Avenue Access Improvements project is included in the adopted 2018-2023 Transportation Improvement Program and the 2018 Annual Construction Program.

### ADMINISTRATIVE POLICY IMPLICATIONS

None.

### COMMUNITY OUTREACH

Community outreach for the Transportation Improvement Program included two work sessions and a hearing with the Clark County Council, presentations to the Clark County Planning Commission, the Southwest Washington Regional Transportation Advisory Committee and the Development and Engineering Advisory Board, as well as a State Environmental Policy Act review and targeted outreach to neighborhood groups and other stakeholders.

Public Works and Western Federal Lands will provide additional outreach where construction will significantly affect drivers and nearby residents.

## INTERLOCAL COOPERATION AGREEMENT Between

## The CITY OF RIDGEFIELD And CLARK COUNTY Under authority of RCW Chapter 39.34

#### For the

## Main Avenue Access Improvements Project

This INTERLOCAL COOPERATION AGREEMENT is between the CITY OF RIDGFIELD, a Washington municipal corporation and CLARK COUNTY, a political subdivision of the State of Washington, for the construction of a bicycle/pedestrian pathway along Main Avenue between the City of Ridgefield and the Ridgefield National Wildlife Refuge.

#### **RECITALS:**

WHEREAS, the City of Ridgefield ("City") and Clark County ("County") are parties to the Western Federal Lands Access Program in partnership with Western Federal Lands, contributing partial funding for the project; and

WHEREAS, Western Federal Lands desires to improve access to the Wildlife Refuge by constructing a pedestrian pathway on parcels of land whose boundaries are generally shown in the attached Exhibit "A". To install the pathway the project also needs to replace two drainage culverts crossing under Main Avenue; and

WHEREAS, both the City and County presently have land use regulatory jurisdiction over portions of the Parcels; and

WHEREAS, the City and the County both have professional planning and permitting personnel on their respective staffs capable of reviewing the proposed pathway; and

WHEREAS, the Shoreline Master Programs in both City and the County, though adopted separately by their respective legislative authorities, are based on a draft master program developed jointly under WAC 173-26 in cooperation with the Department of Ecology; and

WHEREAS, the City and County have found, in the past, that where a project bisects the jurisdiction of a City and County, and applicable regulations in both jurisdictions are substantially equivalent, it is more efficient for either the City or the County to assume review responsibilities over the entire proposal while consulting with the other entity throughout the review process; and

WHEREAS, the parties find that the public interest is advanced by entering into this Interlocal Agreement (ILA), the purpose of which is to allow for Shoreline permitting by the City for construction of the drainage culverts which are located partially outside of the limits of the City of Ridgefield and in the jurisdiction of Clark County.

Main Avenue ILA – Page 1

**AGREEMENT:** NOW, THEREFORE, it is agreed by the City Council of Ridgefield and the Clark County Council as follows:

1. Western Federal Lands plans to construct a pedestrian pathway along Main Avenue and culverts crossing under the roadway. The improvements are located partially on City, County, and Federal property as generally shown in the attached Exhibit "A". The improvements on County property are located on the east side of Main Avenue.

2. This ILA shall be effective on the date it is fully executed by both parties and will terminate on December 31, 2019, unless terminated earlier as provided herein.

3. Western Federal Lands is responsible for all design elements of the project.

4. The City will utilize their resources to process the Shoreline permit for construction of the pathway and culverts which are partially located on county land, subject to the following conditions:

a. The permitting of the public facilities shall apply the City code unless the County code is more restrictive, in which case the County code shall apply.

5. Either party may choose to terminate this ILA by notifying the other party in writing 30 days prior to termination.

6. The City shall respond to, defend, indemnify and hold harmless the County from all claims of liability, damage or injury arising directly or indirectly as a result of the permitting the new facilities unless the claim arises from the intentional acts or the sole negligence of the County, including the County's agents, officers, or employees.

7. The provisions of this ILA may be amended by mutual consent of the parties in writing.

8. Upon obtaining the final approved copy of this Agreement the City will file the ILA with the County Auditor of Clark County, as required by RCW 39.34.040.

9. This ILA shall be executed in three (3) original counterparts, which shall be delivered to the Clerk of the City upon execution of the agreement by the Clark County Council.

This agreement shall be effective upon execution by both City and County Councils.



SUBJECT: Main Avenue Access Improvements, Shoreline Substantial Development

I have been designated by the County Shoreline Administrator and Community Development Director, Marty Snell, to provide documentation for the City's Shoreline Permit demonstrating that the City's application of its SMP to this project will be sufficient to also comply with the standards of the County's SMP.

The County Public Works Department is a partner with the applicant on the project and is currently working with Clark County Community Development and the City to draft a Memorandum of Understanding that will authorize the City to issue and administer a Shoreline Substantial Development Permit on the County's behalf.

I have reviewed the proposed Main Avenue Access Improvements project and City of Ridgefield Staff Report as they relate to Clark County's Shoreline Master Program (SMP) and prepared the attached analysis concluding that the project, as conditioned by the City of Ridgefield, will meet the requirements of the County's SMP.

I understand that the Applicant is soliciting a letter from the Washington Department of Fish and Wildlife that would allow the County to authorize the project under a Statement of Exemption in the event that the MOU between the City and the County cannot be executed in a timely manner.

Therefore, I recommend that Condition 11 in the Staff Report be revised to allow for execution of the MOU in Lieu of a County Shoreline Permit.

## **Applicable Laws:**

40.460 (Shoreline Master Program), Clark County Shoreline Management Master Program, Clark County Comprehensive Plan, and State Laws WAC 173-27 and RCW 90.58.

## **Project Description / Background**

The proposal is to construct paved sidewalk along the west side of Main Avenue from approximately 100 yards north of N Depot St to the Ridgefield city limits, use extensive fill to raise the Main Avenue elevation, and construct one new creek crossing (replacing an undersized culvert) as part of a 0.40-mile project that extends north through Clark County to the Ridgefield National Wildlife Refuge and includes two total creek crossings. No parking or trailheads are planned. There will be no improvements relating to lighting, signage, or utilities.

A small portion of the project is within Clark County's Shoreline Jurisdiction within the Rural Conservancy – Residential Shoreline Designation. Under RCW 90.58, the County does not have Shoreline Jurisdiction on Federal Lands and under Federal Law, the scope of the County's jurisdiction over any Federal Agency is limited in scope to the elements of the County's Shoreline Master Program that pertain to water quality and discharge to waters of the United States. THe Areas subject to the County jurisdiction is limited to the portions of the project within County Right-of-Way for NW Main Ave. and any affected areas outside of the ROW north and east of Gee Creek (see Exhibit "A").

## **Shoreline Analysis**

Since the proposed project will be located in or near waters subject to the Clark County Shoreline Management Master Program, it is subject to the provisions of the Shoreline Management Act. Substantial developments must be consistent with:

(1) Shoreline goals and policies of the Clark County Comprehensive Plan, Chapter 13;

- (2) Shoreline designation purpose and management policies in CCC 40.460;
- (3) Shoreline general regulations in CCC 40.460;
- (4) Specific use regulations in CCC 40.460; and
- (5) Shoreline modification regulations in CCC 40.460.

## (1) SHORELINE MASTER PROGRAM GOALS AND POLICIES

This proposal is deemed consistent with the Shoreline Management Act (90.50.100(2) RCW), the Clark County Shoreline Master Program (SMP), and The Clark County Comprehensive Plan Chapter 13 pursuant to compliance with the standards in Clark County Code 40.460 as described below.

## (2) SHORELINE DESIGNATION

The county classification system consists of shoreline designations that are consistent with and implement the Act (Chapter 90.58 RCW), the SMP Guidelines (Chapter 173-26 WAC) and the Clark County Comprehensive Growth Management Plan. These designations have been assigned consistent with the corresponding criteria provided for each shoreline designation. In delineating shoreline designations, the county aims to ensure that existing shoreline ecological functions are protected with the proposed pattern and intensity of development. Such designations should be consistent with the policies for restoration of degraded shorelines. All the shoreline designations, even if they are not applied within the city limits or urban growth area, are listed here to maintain consistency countywide (see Sections 40.460.440(E) and 40.460.620).

### Analysis

The applicant has verified that they propose to purchase 0.178 credits from the Columbia River Wetland Mitigation Bank to address permanent wetland impacts east of NW Main Ave. The County has verified that the mitigation is sufficient to comply with the County's Shoreline Master Program.

The following analysis addresses only the vegetation conservation zone standards applicable to the proposed development plan where there are issues to be clarified, conditions of approval are warranted to ensure that the standards are met, or the standards cannot be met.

### Analysis

The applicant proposes native planting within 150 ft. of the OHWM of Gee Creek to replace native vegetation cleared for proposed grading. All vegetation cleared can be replaced within 20 year. The proposed plan complies with the County's Shoreline Master Program.

## 40.460.590 Water Quality and Water Quantity

Water quality and quantity standards are generally addressed through compliance with Chapters 13.26A, 40.386, and 40.410 which are normally reviewed under a construction authorization and inspection process.

The following analysis addresses only the water quality and quantity standards applicable to the proposed development plan where there are issues to be clarified, conditions of approval are warranted to ensure that the standards are met, or the standards cannot be met.

#### Analysis

The City of Ridgefield's Findings and recommended conditions of approval related to grading and erosion control are sufficient to comply with the County's Shoreline Master Program.

## (4) SPECIFIC SHORELINE USE REGULATIONS

In addition to the general requirements, all uses and development activities in shorelines are subject to applicable use-specific regulations in CCC 40.460.600. These regulations are intended to work in concert with all sections of the SMP and in particular the goals and policies (CCC 40.460.300) and general use and development regulations (CCC 40.460.500).


#### Analysis

The proposed culvert replacement, tributary realignment will restore water quality functions and specifically benefit threatened and endangered fish species in Gee Creek as required by the County's Shoreline Master Program.

## Findings

Based on the analysis above, The County Shoreline Administrator has made the following Findings of Fact.

- 1. The portions of the proposed trail and culvert replacement project within Clark County's Shoreline Management Area, subject to the Conditions of Approval recommended by the City of Ridgefield's Shoreline Administrator, meet the standards for substantial development under the Clark County Shoreline Master Program.
- 2. Provided that a Memorandum of Understanding between Clark County and the City of Ridgefield authorizing the City to approve and administer a Shoreline Substantial Development Permit on the County's behalf is in place prior to issuance of said permit, a County Shoreline Permit will not be required.




