#### **BACKGROUND**

This project will improve this section of Northeast 119th Street, from Northeast 87th Avenue to Northeast 112th Avenue, to a four-lane minor arterial with center turn lane and median, bicycle lanes and sidewalks. Utility work and stormwater mitigation will be included in this project.

This project will be the latest in a series on the Northeast 119th Street corridor and improves a section between two completed projects. The project is expected to take two construction seasons to build, with completion in fall 2019. For the safety of construction workers and drivers, the speed limit in the construction area will be reduced to 25 mph.

During summer 2018, the contractor will be permitted to close a section of Northeast 119th Street, from Northeast 99th Street to Northeast 102nd Avenue, to all traffic for up to 14 consecutive calendar days. This maximum 14-day closure will happen during an approximately eight-week period, beginning on Monday, July 2, 2018, and ending on Friday, Aug. 25, 2018. The contractor also will be allowed to close this section of Northeast 119th Street for three consecutive weekends.

Variable message signs will notify the public for five days prior to and five days after the traffic restrictions. Specific traffic restriction dates and detour information will be provided to the public in accordance with RCW 47.48.020 Notice of Closure or Restriction and posted on the county website. A Heads Up mailer will be sent out approximately one month before construction begins to notify residents and property owners in and near the construction zone of the upcoming work.

Construction documents are complete. Public Works will advertise the contract for bids upon funding approval from WSDOT Highways and Local Programs. The advertisement is contained in the attached Notice to Contractors.

#### COUNCIL POLICY IMPLICATIONS

None. This project supports the council's policy of investing in the county road system and providing safe and efficient transportation systems for all county residents.

#### ADMINISTRATIVE POLICY IMPLICATIONS

None. The project is included in the 2018-2023 Transportation Improvement Program, 2018 Annual Construction Program (No. 4) and the 2017/2018 Biennium Budget.


