

# CLARK COUNTY STAFF REPORT

**DEPARTMENT:** Clark County Treasurer's Office

**DATE:** April 12, 2018

**REQUESTED ACTION:**

The Clark County Treasurer's Office requests Board of County Councilor approval of a resolution for previously-authorized uncollectible accounts. Uncollectible items include delinquent property taxes, assessments, and fees on business personal and mobile home property accounts.

**BACKGROUND**

Pursuant to RCW 84.56.240, the County Treasurer must submit a list of uncollectible taxes to the Board of County Councilors (BOCC) by the first day of February each year. This list contains accounts in which viable collection solutions beyond statutory remedies do not exist. The Treasurer's Office has completed this requirement on an annual basis. However, prior annual submissions were approved by the BOCC through a staff report and not via a resolution.

It has been discovered that per RCW 84.56.270, in order to submit the previously-approved accounts to Superior court, the Treasurer's Office needs the BOCC to adopt the former submissions in the form of a resolution, which allows extinguishment of the amounts outstanding from the tax rolls.

Attached for consideration are *previously approved* outstanding accounts from the 2009, 2011, 2012, 2013, 2014, 2015, 2016, and 2017 staff reports. The total amount of taxes, assessments and fees of these previously approved accounts is \$446,401. Of which, 22.29% or \$99,501 is attributable to County funds (General Fund, Road Fund, etc.). The remaining amount of \$346,900 represents uncollectable revenues for taxing and special assessment districts within Clark County.

Once these accounts become a full four years delinquent they will be submitted with the BOCC resolution to the Superior Court to permanently extinguish them from the County's tax rolls per RCW 84.56.270.



I, DOUG LASHER, states and declares as follows:

1. I am over the age of 18 years and am competent to testify. I am the elected Clark County Treasurer and I have served in this capacity since 7/5/84. I make this declaration based on personal knowledge.

2. Pursuant to RCW 84.56.270 and for the reasons set forth herein, I request that the Clark County Board of Councilors cancel certain delinquent property taxes that I have determined are uncollectible, which amounts are reflected in Exhibit A.


3. I have employed my staff, utilized County resources and utilized the reasonable means at my disposal in an attempt to collect the taxes specified in Exhibit A, and I find them to be beyond all hope of collection. Such reasonable means of collection may have included but was not limited to: mailing tax statements and delinquency notices to all known addresses of record; making personal phone calls in an attempt to locate debtors; conducting internet searches; reviewing court and newspaper documentation such as obituaries, estate filings, jail records, bankruptcy filings, and divorce decrees; communicating with other government agencies such as the State Department of Revenue, State Department of Licensing, the IRS, the Social Security Administration, and the United States Department of Defense; conducting impromptu on-site visits in an effort to communicate with property owners; and the use of other miscellaneous search tools as appropriate.

4. Upon examination, I find that the cancellation of these taxes and their associated liens will not impair the obligation of any bond issue, nor is the cancellation precluded by any known legal impediment which would invalidate this cancellation.

5. The accounts included in Exhibit A have previously been submitted and approved by the BOCC in prior consent hearings, but are being resubmitted to fulfill the procedural requirement of RCW 84.56.270 that approval be adopted in the form of a resolution.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.

A Resolution to Cancel Uncollectible Personal Property Taxes  
Pursuant to RCW 84.56.240

**WHEREAS**, RCW 84.56.240 directs the County Treasurer to seek cancellation of personal property taxes; and

**WHEREAS**, after diligent search and inquiry if the County Treasurer is unable to collect the personal property taxes, for want of goods or chattels whereupon to levy, the County Treasurer is directed by RCW 84.56.240 to file with the County legislative authority a list of said taxes and an Affidavit stating the inability to collect them, asking the County legislative authority to cancel said taxes from the County tax roll as uncollectible; and

**WHEREAS**, personal property taxes were duly assessed upon the personal property shown on the schedule of personal property appended hereto as **Exhibit A**; and

**WHEREAS**, the schedule of personal property attached hereto as **Exhibit A** are accounts that have been previously approved for submission to Superior Court during prior consent hearings, but have lacked the formal resolution procedurally required by RCW 84.56.270.

**WHEREAS**, the Treasurer attests that diligent search and inquiry for goods and chattels upon which to collect the taxes identified in **Exhibit A** and that such taxes are beyond hope of collection. Attached hereto as **Exhibit B** is the Clark County Treasurer's Affidavit Regarding Uncollectible Personal Property Taxes.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF CLARK COUNTY COUNCILORS:** that the taxes assessed upon the personal property listed on **Exhibit A**, attached hereto, attested by the County Treasurer in **Exhibit B** as beyond hope of collection, are hereby determined to be uncollectible, and such taxes are hereby cancelled from the tax rolls of Clark County pursuant to RCW 84.56.240.


