COUNCILOR COMMUNICATIONS AND DEPUTY COUNTY MANAGER REPORT

Councilor Quiring stated that the Policy Advisory committee decided to put partial tolls on I-5 and 205. She was one of three on a committee of 25 that was from the Washington side, and one of the votes was to go ahead with the pilot. I-5 tolling starts at Going/Abernathy Street to Multnomah Blvd and will be tolled going north and south. All lanes will be tolled. Councilor Quiring said she was one of two individuals who voted no on the pilot project. This has made her more passionate about Clark County being its own economic engine, so the citizens don't have to commute across the river. The tolling will have to get federal approval, and the timing is a few years down the road. Councilor Quiring is hoping to have another letter developed prior to Friday, to give to the Oregon Transportation Committee. Councilors Olson and Stewart also voiced their opinions in regards to tolling.

Councilor Olson stated there were 37 days until the Clark County Fair. She also reminded people of the ordinance passed regarding fireworks.

The councilors thanked Jim Rumpeltes for being the interim county manager for the past year. Jim Rumpeltes recognized Adriana Prata for her work as the budget director, and will be transitioning elsewhere in Clark County.
