2. Request ratification of Staff Report #2018-666, which was previously approved on July 17, 2018, by the Deputy County Manager. This staff report request is for approval to apply for Racial and Ethnic Approaches to Community Health (REACH) through the Washington State Department of Health, increase the Community Health Worker from .6 FTE to .8 FTE, and authorize the Public Health Director to sign any resulting contracts or amendments. The grant term is expected to be five years beginning September 29, 2018, with up to \$402,000 in remuneration.
