BACKGROUND

Clark County acquired Tax Parcel No. 099760-000 with the NE 47th Avenue project (CRP 313822) for a stormwater facility. The original fence line along the east side of the parcel was approximately 10 feet west of the deeded property line. Since the fence line was established more than 10 years prior to the county's ownership the conditions for a claim of adverse possession were met. In addition, the property line passes through two existing structures on the adjacent parcel owned by Rail One, LLC. The county held the fence as the eastern boundary for the stormwater facility tract. This will have no impact on the current or future maintenance and operation of the stormwater facility.

This deed will quit claim 3,277 square feet of Parcel No. 099760-000 to the adjacent property owner, Rail One, LLC.






