BACKGROUND

The Clark County Event Center and its associated funds were incorporated in 2005 into Clark County's financial system with the formation of the Fairgrounds Site Management Group (FSMG) and the subsequent contract between FSMG and Clark County. Previously the Clark County Fair Association could provide petty cash through its ability to write checks against its budget/line-of-credit with Clark County. With the existing contract between Clark County and FSMG, it is necessary to authorize a similar arrangement to enable FSMG to provide petty cash for the annual Clark County Fair from FSMG's budget.

The County Treasurer will deposit \$167,100 into a separate account with Umpqua Bank. These funds will be used for petty cash draws to ticket booths (\$165,000), the vendor ticket office (\$200), and campground, ticket office and concession auditors (\$1,900). The Treasurer will also deposit \$90,000 into this same account for Premium & Awards checks given to exhibit winners. This second deposit is related to Staff Report 261-05, whereby the BOCC authorized the Clark County Fair Association to issue approximately 2,500 checks to winners rather than using the County's check writing process.

Daily Fair petty cash will be re-deposited into this same Umpqua Bank account. Any unused funds will be returned to the County by August 31, 2018 along with receipts of expenditures. A listing of all exhibitor checks issued will be submitted to the County along with any unused funds by October 31, 2018.
