BACKGROUND

The Board of Equalization (BOE) has received approximately 701 petitions to date for the 2018 assessed property values and cannot hear the appeals until after the values are certified by the Assessor, which will occur around September 17, 2018. The BOE also received 867 petitions for the 2017 assessed values and still has 46 of those petition hearings scheduled in the month of September and October of 2018. The BOE is asking to reconvene to extend the hearings beyond the 4 week session of September 24 through October 22, 2018 as they have in prior years. To be able to reconvene the BOE needs the approval of the Board of County Councilors and signatures on the attached document which is kept on file should the Department of Revenue (DOR) audit the BOE.

RCW 84.48.010 states "The county board of equalization shall meet on the 15th day of July or within fourteen days of certification of the county assessment rolls, whichever is later and may continue in session and adjourn from time to time during a period not to exceed four weeks, but shall remain in session not less than three days: PROVIDED, That the County Board of Equalization, with the approval of the county legislative authority may convene at any time when petitions filed exceed twenty-five, or ten percent of the number of appeals filed in the preceding year, whichever is greater."
