#### **BACKGROUND**

The 2019 Preservation ADA Ramp Improvements project will construct or upgrade sidewalk curb ramps to meet current Americans with Disabilities Act regulations prior to pavement preservation work. This annual work is bid in multiple groups due to the large number of locations involved.

Groups 1 and 2 include 47 disabled-accessible curb ramps at 20 locations:

This project was included in the adopted 2018-2023 Transportation Improvement Program (TIP), the 2018 Annual Construction Program (ACP) (No. 22) and the adopted 2018-2019 biennium budget.

#### **COMMUNITY OUTREACH**

This project is included in the 2018-2023 TIP and 2018 ACP. Community outreach for the TIP included work sessions and a hearing with the Clark County Council, presentations to the Clark

County Planning Commission, the Regional Transportation Advisory Committee and the Development and Engineering Advisory Board, as well as a State Environmental Policy Act review and targeted outreach to neighborhood groups and other stakeholders.

In August 2017, Clark County sent an initial notification before starting survey work to residents and property owners in the area. Letters also will be sent to property owners who may have landscaping or other items in the county right of way that is needed for this construction.

Public Works has also developed a one-page handout explaining why the county builds or reconstructs ADA sidewalk ramps on street corners prior to some preservation projects. That handout is posted on the county's website and will be used in community notification and outreach as needed.

Sealed bids shall be delivered to the office of Clark County Purchasing, Public Service Center, 1300 Franklin Street, Suite 650, Vancouver, Washington 98660 (or P.O. Box 5000, Vancouver, WA 98666-5000). Bids delivered to locations other than as indicated above or received after the time indicated above will not be accepted. Bids will be publicly opened and read aloud at 2:00 P.M., or as soon thereafter as possible, on the same day in the Hearing Room of the Board of County Councilors, 6th Floor of the Public Service Center.

Description of work: Improve sidewalks and ADA ramps, including curb and pavement restoration, and detectable warning surface retrofits, at various locations in Clark County.




