REQUESTED ACTION: Approve grant proposal to the Lower Columbia Fish Recovery Board to develop outreach materials to train and assist residents, contractors and landscapers with private stormwater facility maintenance.

BACKGROUND

Clark County and other members of Stormwater Partners of SW Washington see a need for additional easy-to-understand outreach materials for stormwater facility maintenance targeted to homeowners associations, contractors and landscapers.

This grant proposes to develop resources outlining best maintenance practices, including printed materials, digital tools and videos for posting on Clark County's and Stormwater Partners' websites.

Clark County is a member of the Stormwater Partners of SW Washington, along with the cities of Battle Ground, Camas, Ridgefield, Vancouver and Washougal. Stormwater Partners was originally formed through a Washington State Department of Ecology grant to develop educational resources about stormwater facilities. This proposal will build on past efforts to create materials specifically related to maintenance practices.

Expected outcome if this grant proposal is approved include:

- Improving efficiency and effectiveness of outreach to private stormwater facility owners.
- Providing consistent materials countywide.
- Strengthening Stormwater Partners and leveraging resources.

Expected disadvantages if staff report is not approved:

- A sustained increase in staff time to explain and clarify best maintenance practices.
- Less efficient outreach efforts.
- Potential costly repairs for private stormwater facility owners unaware of their maintenance responsibilities.
