We plan to dispense naloxone and educate Clark County personnel working with the populations most at risk of opioid overdose and most likely to be first responders, including Public Health, Department of Community Services, Therapeutic Specialty Courts, probation and law enforcement. Education for clients, friends and family members is also done through this collaboration. We currently provide injectable Naloxone at our syringe exchange, as well as special trainings for first responders outside of syringe exchange. Each year, the need for Naloxone is increasing.

Our department and partnering departments lack funding for purchasing adequate supplies of nasal Naloxone. Dispensing will be done under a standing order through Public Health.
