
### **REGULAR SESSION:**


1. Commissioners reviewed and took action (certified for one year or until exhausted) on the following eligibility list:

3. Business to come before the Commission
  - a. Update on vacancy – Secretary Harrington Smith shared the latest news on the Commission vacancy. The decision rests with the Clark County Board of County Councilors per RCW 41.14.030. The BOCC identified their top 2 candidates and had previously expressed a desire to interview them.
  - ~~b. Skamania County Corrections will likely be laying off Corrections staff and the Chief Deputy of the Jail has asked the Commissioners to consider allowing Clark County to absorb the Skamania County employees. The Commissioners discussed the matter and as much as they would like to accommodate the request, the current Corrections Deputy eligibility list would be compromised,~~

and there is unfortunately no provision in the Civil Service Rules to accommodate this situation. **Update from 2/13/15: Clark County Sheriff's office has withdrawn this request.**




