PUBLIC HEALTH IN ACTION

Mosquito Control District

Clark County Mosquito Control District, Earl Fleck, Secretary & Treasurer provided some background information on the history and structure. Prior to 1982 mosquito control was a function of the SW Washington Health District. CCMCD was established by vote of Clark County residents in 1982. The Board of Trustees includes 10 members as prescribed by the bylaws with three being from Clark County.

John Jacobson, Operations Manager, provided background information on the work plan and various methods used to monitor and control mosquito populations for Clark County. Objective of mosquito management is to keep populations below levels where they become a nuisance or a public health problem leading to an outbreak of disease. Integrated pest management is the primary focus on immature mosquito abatement which is endorsed by WA Dept. of Ecology and CDC. Service line number is 360-397-8430. There are around 20-30 different mosquito species in Clark County. Breeding sites are standing water, storm water facilities and storm drains. No vector-borne Zika spread are anticipated at this time however the Mosquito Control District will continue to enhance its role in the Zika virus situation. Further discussion ensued.




