PUBLIC HEALTH IN ACTION

Alan Melnick, Public Health Director / Public Health Officer introduced staff and presenters.

Repair Café:

Sally Fisher, Public Health Environmental Outreach Specialist, presented and gave a brief background on her job and what she does. Sally works in the Solid Waste and Environmental Outreach program which includes: recycling, garbage and working with the public for more sustainable lives. The Repair Café is a fairly new program and an opportunity for people to bring in things that are broken for skilled volunteer fixers who will fix them. The first one was held at the Habitat Store, was very successful and had little advertisement. The long term goal is to turn the program over to volunteer groups who will manage the events and run it.

Recycled Arts Festival:

This year the event will take place on June 24 & 25, 2017 at Esther Short Park and will be the 12th year of the event. The primary purpose of the event is to educate on sustainable living practices with art and celebration. The hope is to spark positive consumer behavior within the community and reduce waste. *Procession of the Species* is a new feature this year. The idea started in Olympia and is basically a parade with costumes, floats, music, and dancing with animal and element themes. It is a celebration of community and the natural world with a goal to connect people to nature.






