Guest speakers

Susan Gilbert, Enterprise/Paradise Point, Cowlitz Tribe update:

- The coalition plaintiffs consisting of the City of Vancouver, Clark County, Confederated Tribes of the Grand Ronde, Citizens Against Reservation Shopping, Al Alexanderson and Susan and Greg Gilbert lost the first round in DC District Court last December. The case is being appealed and the appeal decision should be made sometime the summer of 2016.
- The Bureau of Indian Affairs took the Cowlitz land into trust in March even though there is continuing litigation.
- Because the *Carciere v. Salazar 2009*, won its case in front of the Supreme Court of the US which held that the term "Now under federal jurisdiction" referred only to tribes that were federally reorganized when the Indian Reorganization Act became law in 1934, this decision meant that the Cowlitz were not among the tribes that were "recognized". Therefore, they cannot, by that decision, enjoy the rights of recognized tribes which includes having land taken into trust. The judge in the DC District Court went against the US Supreme Court Decision which makes it more favorable to us that the case may be heard if either side loses in the appeal.
- A side problem is that the Growth Management Hearing Board has turned down twice a request by the City of La Center to extend sewer west to I—5. It said service cannot be delivered over rural lands to a development. It said that the City of La Center who wants to provide sewer and Clark County need to work on consistency of their respective growth plans.

Marty Snell, Director of Clark County Community Development, Developing and Permitting Process

Marty began his presentation by stating the county has a vested interest in economic recovery. He reviewed the effects of the recession and provided information about development issues, trends and initiatives. He also talked about the new permit center and how the culture is one of assistance and expediency.
