1. **Secretary of State (SOS) Voter Registration Database (VRDB)**: Victoria Lenoir, the above-listed voter, is identified as living at residential address 1228 E 1st Avenue, Apt 102, Camas. Her mailing address is listed as PO Box 307, Washougal WA. Research support below indicates that she does not reside at the VRDB residential address. **See attached.**
2. **Affidavit From Current Resident**: An affidavit was obtained from the current resident, Nolan Camacho, at the apartment address who verified that Victoria Lenoir does not live there. **See attached.**
3. **Certified Mail Receipt**: A required attempt was made to contact Victoria Lenoir at the registered mailing address in Camas via a letter and a USPS certified mail receipt with a request to update her residential address. A National Change of Address (NCOA) became effective on November 1, 2021, with an address of PO Box 307, Washougal WA 98671. **See attached.**

5. **Cyber Background Checks**: For website <https://www.cyberbackgroundchecks.com/> no data was available for Victoria Lenoir.
6. **GIS Property Tax Records**: Victoria Lenoir does not own any real property in Clark County, as confirmed via phone with Nate at the Treasurer's office who checked online in the county's geographic information system (GIS). A check on the GIS website <https://gis.clark.wa.gov/gishome/Property/> indicates the registered residential apartment building at 1228 E 1st Avenue, Camas address is owned by First Place Garfield Apartments LLC in Washougal WA, and purchased in November 2015. **See attached.**
7. **Voter Registration Verification**: Website <https://voteref.com/voters/> indicates Victoria Lenoir is registered to vote at 1228 E 1st Avenue, Camas. **See attached.**
