1. **Secretary of State (SOS) Voter Registration Database (VRDB)**: Casey McEnry, the above-listed voter, is identified as living at residential address 1631 NE 5th Court, Camas. He also has a separately listed address, PO Box 410, Camas WA. Research support below indicates that he does not reside at the VRDB residential address. **See attached.**
2. **Citizen Affidavit**: An affidavit was obtained from the voter's mother, Debra McEnry at 3007 NE 2nd Avenue, Camas. She verified that Casey McEnry does not live at 1631 NE 5th Court, nor has he lived in Washington State for over 10 years because he currently lives in New York. She was very upset and annoyed; she said they have attempted multiple times to cancel Casey's voter registration with the Elections office, to no avail. **See attached.**
3. **Certified Mail Receipt**: A required attempt was made to contact Casey McEnry at the registered mailing address in Camas via a letter and a USPS certified mail receipt with a request to update his residential address. **See attached.**
4. **Search People Free**: Website <https://www.searchpeoplefree.com/> indicates that Casey McEnry has a current mailing address at 68 2nd Place, Apt 1, Brooklyn, NY 11231. Multiple possible phone numbers for him are listed. **See attached.**
5. **Cyber Background Checks**: Website <https://www.cyberbackgroundchecks.com/> indicates that Casey McEnry has a current mailing address at 68 2nd Place, Apt 1, Brooklyn, NY 11231. Multiple possible phone numbers for him are listed. **See attached.**
6. **GIS Property Tax Records**: Casey McEnry does not own any real property in Clark County, as confirmed via phone with Sabina at the Treasurer's office who checked online in the county's geographic information system (GIS). A check on the GIS website <https://gis.clark.wa.gov/gishome/Property/> indicates the registered residential 1631 NE 5th Court, Camas address is owned by Andrew and Chizuko Bradley and purchased in June 2018. **See attached.**
