1. **Secretary of State (SOS) Voter Registration Database (VRDB)**: Jason Perman, the above-listed voter, is identified as living at residential address 1416 E 1st Avenue, Camas. He also has a separately listed mailing address, PO Box 624, Yacolt WA. Research support below indicates that he does not reside at the VRDB residential address. **NOTE: See attached.**


