1. **Secretary of State Voter Registration Database (VRDB)**: Kolten Snyder, the above-listed voter, is identified as living at residential address 904 East 1st Avenue, Camas. He also has a separate mailing address listed in Woodland, WA. Research support below indicates that he does not reside at the Camas address. **See attached.**
